### **REGULAR AGENDA ITEMS**

- 1) Discuss Land Acquisition: No Discussion/No action taken.
- 2) <u>Discuss Tranquility Garden benches and fountain:</u> Steve Albright reported he has not received the contract from Liquid Gardener for the installation of the fountain. Norman Koepernik will contact the electrician and plumber to prepare for the fountain installation upon approving Liquid Gardener's contract.
  - Norman has been in contact with Palomar Furnishings to purchase teak benches. They are currently out of stock.
- 3) Review design plan for Block 76: Steve Albright reported he had sent the two columbarium drawings to Lee+Associates for reproduction. Josh Bernsen suggested the Board select just one of the drawings for now. The Board selected plan A. Steve will work with Josh to have the new drawing for the next Board meeting.
  - Norman Koepernik presented the concept of a metal memorial tree to the Board.
- 4) Report on the Madronia entrance arch: Norman Koepernik reported he went to Brian Cook's shop to access the progress of the Madronia arch. Brian had repaired the scrolls and is working on replacing the legs. Brian would like the Board to select the desired finish.
- 5) Review Resolution 2024-2: The Board reviewed Resolution 2024-2 to move \$133,000.00 of County funds to Stifel Endowment Care Interest. Vicky Bosworth moved to pass Resolution 2024-2. Sue Fitzpatrick seconded the motion. Unanimous.

#### 6) Manager's report:

- **a.** Steve Albright asked the Board for details of the Special meeting held on October 5, 2022 so he can complete the minutes.
- b. Steve Albright reported he had received a power of attorney from Huimin Mu which gives her authority to purchase interment rights for brother. She also wants to use the power of attorney to purchase interment rights for her children through her brother. Steve forwarded the documentation to District attorney, Kirsten Powell to review. Kirsten responded the documentation does not give the brother authorization to purchase for her children. The Board requested the March agenda include a review of A.R. 502 Restrictions on Sale of Interment Rights.
- c. Steve Albright reported he had been contacted by Sandra Wheeler of Stifel Investments. Sandra emailed Steve information about the Stifel product Smart Rate. Sandra encourages the Board to invest extra BMO funds in Smart Rate for a higher yield of investment. Steve will add Stifel Smart rate discussion to the March agenda.
- d. Steve Albright presented the invitation to the Saratoga City Council Joint Session meeting on April 17, 2024. The Board has been invited to give a ten minute presentation to the City Council during the meeting. Steve will add "Plan for the Saratoga City Council Joint meeting" to the March agenda.
