- Discuss and approve ADU located on APN 517-04-068: The Board discussed the ADU unit located on APN 517-04-068. The Board considered closing on the property purchase before the ADU is permitted by the County or wait for the permit before closing. Vicky Bosworth moved to move forward with the purchase without ADU permitting resolved. Norman Koepernik seconded the motion. Unanimous.
- 2) Review and discuss progress of the Lomita property repairs and improvement: Steve Albright reported he has been working on the swimming pool removal Request for Proposal. The RFP will go out by July 1st.
- 3) <u>Discuss Block 76 development:</u> Steve Albright reported he has spoken to a cemetery architect to draw the grave and columbarium for the District. The Board would like all the trees removed along Redwood Circle S in Block 76.
- 4) Review and approve Request for Proposal for grading, roads and swimming pool removal:

 Steve Albright presented the RFP for grading, roads and Pool removal to the Board. Vicky

 Bosworth moved to accept the proposed RFP with the revision discussed. Sue Fitzpatrick
 seconded the motion. Unanimous.
- **Report on BMO account activities and approve signing signature cards:** Steve Albright reported there have been no unauthorized withdrawals from the BMO account in the last 90 days. The Board approves signing new signature cards. Steve will schedule the date for signing on a Thursday.
- **Discuss ADA Website compliance:** Steve Albright reported he spoke to Jeff Johnson about providing the District with an ADA compliant website. Jeff responded he was not interested in developing an ADA compliant website for the District. The Board will continue with the current website with Jeff Johnson.
- 7) Report on Strawberry Tree for Block 86: Steve Albright reported he has selected a 36" Strawberry tree for the District, but has not received an invoice from Moon Valley Nursery. Steve will arrange to make payment and schedule installation.
- 8) Approve 2024-2025 budget revision: The Board reviewed the 2024-2025 Budget for revision. Vicky Bosworth moved to revise the Professional Services category from \$14,000.00 to \$30,000.00. Norman Koepernik seconded the motion. Unanimous.

- 9) Review and approve Fiscal year 2025-2026 Budget: The Board reviewed the proposed 2025-2026 Budget. The Board would like to increase the Insurance category from \$30,000 to \$40,000. Sue Fitzpatrick moved to accept the fiscal year 2025-2026 Budget as presented with the adjustment to the Insurance category. Motion seconded by Vicky Bosworth. Unanimous.
- **10)** <u>Discuss issue of missing flowers:</u> The Board commented on the letter submitted by Nazi Ghotbi. The Board considered several options with no resolve. The Board wants Steve Albright to respond to Nazi's letter.
